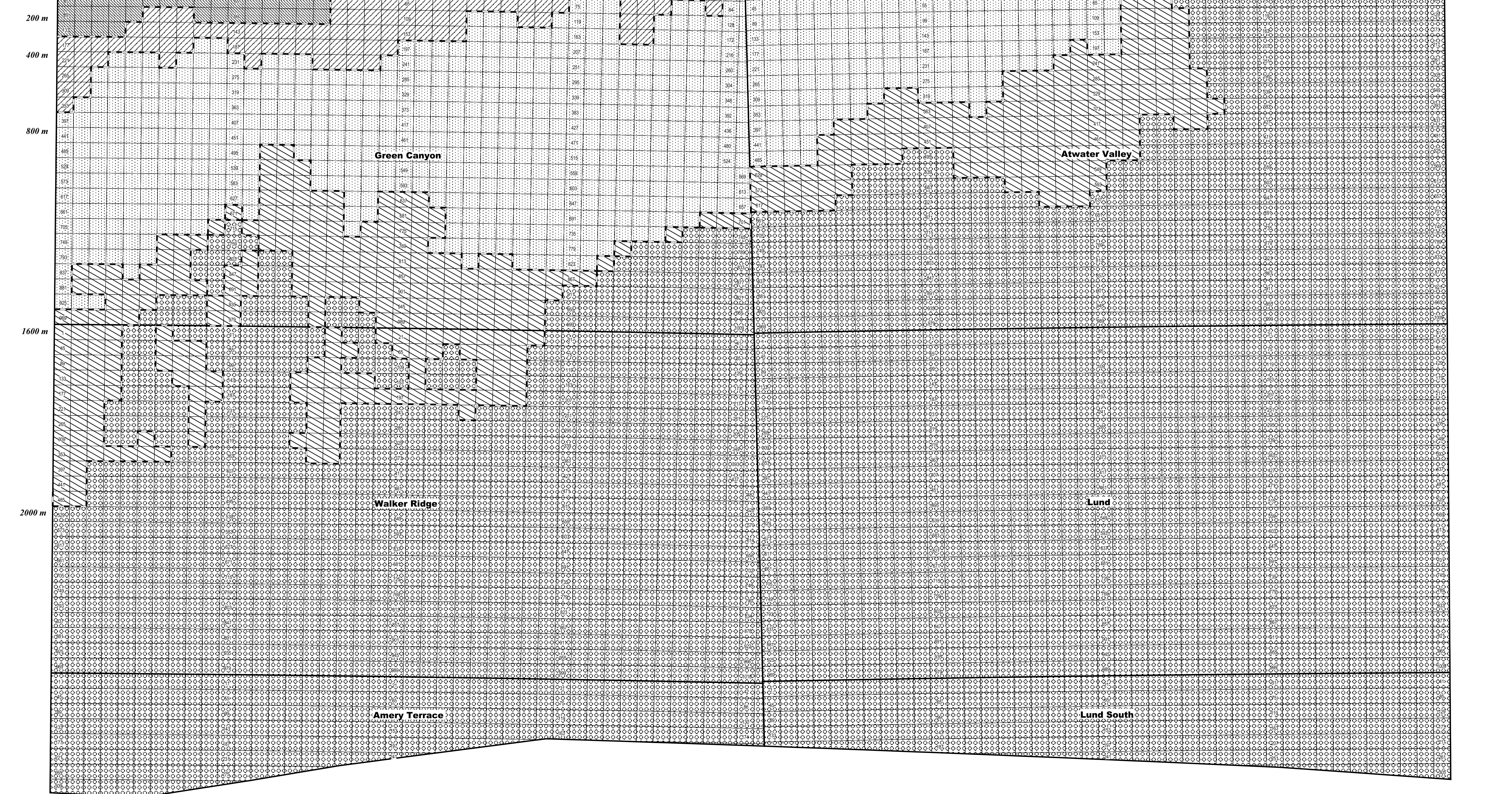

LEASE TERMS AND ECONOMIC CONDITIONS**

- Water depth (meters)
- 5 Year Initial Period, \$25 Per Acre Minimum Bonus Bid, \$6.25 Per Acre Rental/Minimum Royalty Rate, 16 2/3% Royalty Rate, and Shallow Water Deep Gas Royalty Suspension Area**
Includes all blocks in the Louisiana Leasing Map areas, EXCEPT South Pass 50 and 51, which are in the zone described immediately below.
