I've excerpted the information about the DVDs and map from the above-linked document below: "In addition to the project description (Beta Offshore, LLC, 2010), Beta Offshore submitted a set of DVDs containing a remotely operated vehicle survey of the seafloor, including sonar sweeps, which were used to detect seafloor anomalies such as hard bottom. A map was also submitted which depicted the project area, the proposed location of the laydown area of the new replacement pipelines, known hard bottom areas, the location of existing power cables, pipelines, and other features." This request is for the above-mentioned "set of DVDs" and map. It is a narrowly focused request seeking only those specific materials. I hope this can be accelerated due to the timely importance of these materials in light of the recent oil spill. I appreciate your attention to this matter. I am simultaneously submitting this request to the BSEE because it is unclear which of the two agencies would have retained these records. Thank you in advance.
