Dear Dr. Rea:

On behalf of Bureau of Ocean Energy Management (BOEM) I thank you for accepting the position of Chair of the BOEM Outer Continental Shelf Scientific Committee (OCS SC). I look forward to working with you.

Thank you for your letter dated February 3, 2012, detailing your comments from the OCS SC meeting last year in Hyannis, Massachusetts on May 17-19, 2011. I am writing to respond to your comments and recommendations.

In regard to the Environmental Studies Program (ESP) budget, you pointed out that the “budget needs to be further increased in light of the Bureau’s expanded geographic scope of the leasing program and expanded scientific assessment required for development of renewable energy in the OCS.” I agree, and BOEM’s FY 2013 budget request includes additional funding for ESP (http://www.doi.gov/budget/2013/data/greenbook/FY2013_BOEM_Greenbook.pdf).

Unfortunately, given the current fiscal situation affecting all Federal agencies, budget outlooks are uncertain. Nevertheless, I am confident that the ESP, with guidance from the OCS SC, can maintain its commitment to excellence in conducting applied science for informed decisions on ocean energy. Unfortunately, this may have to be accomplished by reducing the scope of some studies, or delaying or cancelling lower priority studies. As always, partnerships and collaborations will be sought to leverage limited budgets and extend the utility of the work conducted.

As part of the Interior Department's structural reform of offshore energy oversight BOEM has added subject matter experts in all of our environmental programs. Additionally, the position of Chief Environmental Officer of BOEM was established to oversee the integration of BOEM's rigorous scientific analysis with resource development and decision-making. Dr. Alan D. Thornhill was named the first Chief Environmental Officer of BOEM in November 2011.

Dr. Thornhill is responsible for directing BOEM's programs for studying the offshore environmental issues necessary to support responsible decision-making about resource development, managing the National Environmental Policy Act (NEPA) review process, and developing national priorities for scientific research relating to the oceans.

Additionally, Dr. Mary Boatman joined the Renewable Energy Program as the Environmental Studies Chief. Dr. Boatman has been working with ESP since 1998 and most recently was instrumental in the National Ocean Council's National Ocean Policy (NOP) Implementation plan, and the implementation of the data portal at <http://www.data.gov/ocean>.

The ESP is also expanding its ability to work with academia through the Cooperative Ecosystems Studies Units (CESU). CESUs are a national consortium of Federal agencies, academic institutions, tribal, state, and local governments, nongovernmental conservation organizations, and other partners working together to support informed public trust resource stewardship. The ESP has joined all coastal units that meet the bureau mission, and has nine ongoing studies and seven new starts for 2012 under CESU agreements.

Dr. Rodney Cluck, Chief, Division of Environmental Sciences, was named co-chair to the National Ocean Partnership Program's (NOPP) Subcommittee on Ocean Science and Technology's Engagement with the Interagency Working Group on Ocean Partnerships (IWG-OP). The IWG-OP facilitates partnerships and collaboration among the Federal oceanographic community. The importance of the NOPP and this program to the Nation is evidenced by its statutory creation by the U.S. Congress in 1997 through Public Law 104-201. Regular participants include BOEM, NOAA's Office of Oceanic Atmospheric Research, Integrated Ocean Observing Systems, Office of Exploration and Research; NASA, ONR, NSF, DOE, Army Corps of Engineers and the US Navy.

The ESP is continuing agreements with two Coastal Marine Institutes (CMI), Louisiana State University (LSU) (<http://www.cmi.lsu.edu/index.php>) and the University of Alaska at Fairbanks (UAF) (<http://www.sfos.uaf.edu/cmi>). CMI programs are designed to respond to BOEM, State, and local information needs and interests with local expertise in the OCS-relevant disciplines. The LSU CMI was established in 1992, and celebrated 20 years of collaborative research in a celebration on April 24, 2012. Over \$30 million in research agreements have been awarded by BOEM to 140 studies through the LSU CMI program. In addition to funding the research of scientists at LSU, more than 100 graduate and undergraduate students have been supported through these projects. The UAF CMI has undertaken more than 60 studies with \$15 million in research agreements since 1993.

In regard to Recommendations 1 and 2 noting a desire for multiple meetings per year and support for travel to Information Transfer Meetings (ITMs), I agree that it would be very valuable for the OCS SC to meet twice per year: once to advise on future studies, and once to receive updates on studies in progress. While BOEM supports this request, the ability to hold multiple meetings in any given year will be dictated by agency funding levels. I also agree that members of the committee should be encouraged and supported to attend one or more ITMs each year. These meetings provide an excellent opportunity to interact with studies investigators and receive updates and results of ongoing studies. Dr. Cluck will coordinate with the members of the OCS SC on this point.

Regarding Recommendation 3 on promoting peer review and external publication of BOEM funded studies, BOEM is committed to supporting the peer review and publication of ESP funded studies. This begins with encouraging and supporting BOEM scientists to write and publish in peer-reviewed publications, and continues with encouraging BOEM-funded scientists

to publish the results of BOEM research (including BOEM paying for publication fees). That being said, it is not possible to make it a requirement of contracts for BOEM funded scientists to publish in peer reviewed publications, as it is out of the control of both BOEM and the PIs as to whether or not a journal will accept a specific paper for publication.

ESP scientists are also encouraged to utilize outside experts (particularly the OCS SC members) to assist in proposal evaluation, at their discretion, and have been encouraged recently to utilize these types of peer and external review as often as is appropriate. Additionally, BOEM utilizes its involvement with the NOPP and other entities in this capacity.

An enclosure has been prepared to address the issue raised in Recommendation 4, regarding the status of projects presented to the OCS SC. It lists studies presented in the past two Studies Development Plans (SDP) and studies added outside the SDP process. The status of funding, start date, expected finish date, and total budgets are listed.

To respond to Recommendation 5 on increasing social science capacity in the Gulf of Mexico (GOM) Region, the GOM Region studies staff has been reorganized such that a dedicated socio-economist reports directly to the Studies Chief in the region. An additional economist has also been added to the GOM scientific staff to aid in studies development and analysis. Further, we anticipate at least one or two new socio-economic studies to be presented at the May 2012 OCS SC meeting to address issues resulting from the Macondo incident, and a similar scenario with new studies at the 2013 OCS SC meeting. To address your concern about staffing levels for socio-economic subject matter experts in the GOM Region, we are again constrained by the current federal budget situation, but are constantly evaluating priority staffing needs and making balanced decisions based on the needs of the entire Bureau.

In regard to the Pacific Region's funding needs to support renewable energy research addressed in Recommendation 6, each region is apportioned ESP funds for studies in a manner that reflects their requests. They base their requests on immediate and anticipated science needs. If the Pacific Regions' needs increase, funding will be allocated appropriately and staffing needs will be evaluated as noted above. The ESP also anticipates an increase in needs regarding renewable energy development and will respond based upon the requests submitted by the region.

As noted in last year's response letter from former Bureau of Ocean Energy Management, Regulation and Enforcement Director Michael Bromwich, the ESP has reviewed your excellent recommendation for prioritizing studies and has incorporated these criteria into the decision-making process used to develop the National Studies List. Final decisions are of a collaborative nature, made in discussions between BOEM ESP staff in headquarters and in the regions to best address Bureau needs. The decision process begins with regional scientists and managers creating a priority list for each fiscal year, followed by discussing these priority lists with regional and headquarters Studies Chiefs to reach consensus on which studies move forward.

In response to your additional Recommendation 1 which addresses ocean planning activities, BOEM is engaged significantly with the ongoing Ocean Planning initiative. Ocean planning is an important tool for implementing Ecosystem Based Management which is at the heart of the integrated resource management approach promoted by the National Ocean Policy (NOP). BOEM has considerable experience in planning processes like those intended to be implemented

by the NOP. The Five-Year Program for oil and gas and the Renewable Energy Program both require comprehensive, transparent planning processes and extensive stakeholder outreach (through scoping, task force, and other public meetings). This experience is extremely valuable as BOEM participates in ocean planning activities in various regions. BOEM is the DOI lead for coordinating ocean planning efforts under the NOP, and also is the Federal co-lead in the Mid-Atlantic region and potentially in the Alaska region. BOEM is engaged significantly in other regions with interest in developing energy and mineral resources on the OCS: Northeast, South Atlantic, GOM and the West Coast. Additional BOEM experience includes creating data linkages with the Multipurpose Marine Cadastre (MMC), the NOP data portal (www.data.gov/ocean), and with other regional data portals. It is critical for BOEM to ensure that science dissemination is occurring so that regional ocean planning initiatives are able to utilize the full extent of BOEM science.

With regards to your additional Recommendation 2 on increasing international studies coordination, I am pleased to note that the ESP has begun new studies in collaboration with Canada and Russia, and continues a fruitful relationship with counterparts in Mexico. These studies address important fish stocks, pinniped populations and physical oceanographic topics respectively. I agree wholeheartedly that these types of scientific collaborations should be encouraged and increased as appropriate to meet our important stewardship mission.

To address your final additional recommendation regarding the Discipline Breakout Groups (DBG) scheduling, ESP staff has reviewed the scheduling of the DBG presentations. As a result, adjustments have been made to meet the needs of the OCS SC and foster the valuable scientific dialogue that needs to take place to develop a strong scientific portfolio for the coming years. Please let me know in your response to this year's meeting if this new agenda meets the needs of the OCS SC.

I offer my sincere thanks for your service to the Nation and BOEM and look forward to working with you and the OCS SC in the future.

Showing Approval and Award Status

The following table is provided in response to the request from the Scientific Committee (SC) included in their letter of February 3, 2012. The table lists the studies presented to the SC in Studies Development Plans (SDP) for the previous two fiscal years and the current plan. It also lists studies that were added to the National Studies List (NSL) without appearing in an SDP.

The table is arranged first by Region and then by NSL number (an internal tracking number indicating that the study was approved to move toward procurement. Studies without an NSL number have not been approved to move towards procurement and are listed in order of the most recent plan in which they appeared and then in alphabetical order by title.

An "X" in an SDP column indicates that the profile appeared in that plan. If a study was added outside the SDP process, no "X" is shown in any of the three SDP columns.

In the column "Approved in FY," the fiscal year in which the study was approved on the NSL for procurement is given. A "TBD" in this column indicates that the study is in the current plan and has not been presented for approval on the FY 2013 NSL yet. A "N/A" in this column indicates that the study was not approved for inclusion on the NSL after appearing in a previous year's SDP.

In the column "Awarded in FY," the fiscal year in which the study was awarded is given. A "Cancelled" in this column indicates that the study was approved on the NSL, but was later cancelled. A "Deferred" in this column indicates that the study was approved on the NSL, but will not be moved toward procurement until FY 2013 or later. A "TBD" in this column indicates that the study is in the current plan and has not been presented for approval on the FY 2013 NSL yet. A "N/A" in this column indicates that the study was not approved for inclusion on the NSL after appearing in a previous year's SDP.

In the column "Total Allocation," the total dollar amount planned for awarded studies is given. A "Cancelled" in this column indicates that the study was approved on the NSL, but was later cancelled. A "First Submission" in this column indicates that the profile appears only in the current SDP. A "Repeated Submission" in this column indicates that the study appears in the current SDP as well as in one or both of the previous two SDPs. A "Not Approved" indicates that the study was not approved for inclusion on the NSL.

In the column "Award Date," the date of contract or agreement award is given. A "TBD" in this column indicates that the study was approved on the NSL, but the award has not been completed. Studies have no entry in this column if they were cancelled or deferred, if they are in the current plan, or if they were not approved for inclusion on the NSL.

In the "Completion Date" column, the expected completion date of awarded studies is given. No other studies have entries in this column.
