Winners of the MMS Corporate Leadership Award work in many capacities in the energy industry and win the award for performing an act or service that enhances the MMS mission of securing ocean energy and economic value for America.

Winners are nominated by MMS employees who have first-hand knowledge of the recipients' exemplary on-the-job performance. The award honors individuals in the energy industry who excel in their work, care about the environment and meet their fiscal responsibilities.

The Minerals Management Service is the Federal agency in the U.S. Department of the Interior that manages the nation's oil, natural gas, and other mineral resources on the Outer Continental Shelf in Federal offshore waters. MMS also collects, accounts for and disburses mineral revenues from Federal and American Indian lands. MMS disbursed more than \$8 billion in 2003 and more than \$135 billion since the agency was created in 1982. Nearly \$1 billion from those revenues go into the Land and Water Conservation Fund annually for the acquisition and development of state and Federal park and recreation lands.
