Oregon Wind Lease Issuance Draft Environmental Assessment Public Meeting

Tuesday, May 21, 2024

1:00 p.m. – 4:00 p.m. PT

# I. Introduction

As part of the public comment process, the Bureau of Ocean Energy Management (BOEM) hosted two virtual public meetings to present the Oregon Draft Environmental Assessment (Draft EA or "Draft") and gather public input on the content of the Draft. This summary covers the first of the two meetings (the second took place on June 5, 2024).

The meeting was held remotely via webinar using the Zoom platform. 127 participants attended. Government participants included representatives from federal and state agencies, Tribes, and local governments. Participating members of the public included representatives from industry, academic and research institutions, non-governmental organizations (NGOs), community-based organizations (CBOs), and the media. The meeting began at 1 p.m. and ended at approximately 3:30 p.m.

# II. Discussion Highlights

## a. Welcome, Introductions, and Agenda Review

Jamie Damon, K&W facilitator, welcomed public attendees to the meeting. She shared webinar instructions for attendees, reviewed participation ground rules and reviewed the agenda for the meeting.

# b. Opening Remarks

Lisa Gilbane, BOEM, Chief of Pacific Environmental Analysis Section, gave opening remarks and welcomed attendees. She presented an overview of BOEM's mission and authority, including its regulatory authority to issue leases for offshore wind (OSW). She highlighted that the purpose of this meeting is to learn more about and comment on the draft EA.

# c. Wind Energy Leasing Authorization Process

Jean Thurston-Keller, BOEM, Renewable Energy Specialist and Oregon Task Force Coordinator, provided an overview of the BOEM wind energy leasing authorization process. She shared more details about the main phases of the process, including planning and analysis, leasing, site assessment, and construction and operations. She discussed how BOEM consults with state, local, and Tribal governments throughout the process. She then provided background on the renewable energy process, including a call for information and nominations (call), wind energy areas (WEAs), and lease areas. Jean shared a history of BOEM's involvement in OSW in Oregon. She provided an overview of the final WEAs and lease areas offshore Oregon and displayed a map of these areas. She noted that the next step in BOEM's process is to review comments received on the Proposed Sale Notice and Draft EA, and finalize the EA. The Consistency Determination process by the State of Oregon will be completed through the Coastal Zone Management Act.

#### d. Overview of Draft EA

Linette Makua, BOEM, NEPA Coordinator, shared a background of NEPA, the proposed action, and an overview of the draft EA, and next steps related to the EA. She reminded attendees that BOEM is not currently looking at the development or construction of specific OSW projects, but rather the potential impacts of leasing activities such as site assessment and characterization. Linette shared an overview of how NEPA guides BOEM as it considers potential impacts, including environmental, social, economic, natural resources, and historic preservation factors.

Linette then provided more information about the proposed actions in the draft EA, including issuance of commercial wind energy lease(s) and site characterization and assessment activities. She discussed cable route corridors and highlighted that BOEM does not currently know the

locations of cable corridors because no project has been proposed yet. She then shared an overview of public comments from the scoping process.

She shared more details about each resource assessment in the draft EA, including the affected environment, potential impacts, and estimated level of impact. Specifically, she discussed cultural resources, commercial fishing, and marine and coastal habitat and associated biotic assemblages.

Finally, Linette discussed the next steps in the NEPA process, including finalizing the EA in the summer of 2024.

### e. Clarifying Questions on the Draft EA Process

Jamie Damon, K&W, facilitated a question-and-answer session during which BOEM staff answered questions from attendees. Key themes among the questions include:

- Scope of the Draft EA: Members of the public asked specific questions about the scope of the EA, including about inclusion of the Morro Bay leasing areas due to the California Current Large Marine Ecosystem and migratory species in the region and the inclusion of additional ports along the Oregon coast, such as Florence and Reedsport. Attendees asked about the ways BOEM considered cumulative impacts of OSW development, including land-based activities in the analysis of cumulative impacts and about the inclusion of intertidal and coastal habitats in the draft EA.
- <u>Data Sources</u>: Attendees asked about the data and research sources used in the draft EA.
   Questions were asked for clarification about which datasets were used to determine important habitat considerations and which agency or agencies decide which datasets and/or research to use for the EA to determine the impacts of construction and operations once COPs are submitted. An attendee asked for greater insight into how BOEM determines impact determinations, e.g. "negligible" or "moderate."
- Potential Impacts on Marine Wildlife: Attendees raised questions about the EA's
  consideration of impacts on marine wildlife, such as migratory birds, sea turtles, and
  marine mammals. There was concern about stronger protections for marine mammals
  related to vessel speed and proximity, and questions were asked about BOEM's
  requirements for lessees to mitigate impacts to marine mammals. Questions were also
  asked about research on the impacts of transmission cables and turbine noise on marine
  wildlife. Several members of the public raised concerns about the potential for oil spills and
  asked BOEM to include the potential impact of oil spills in its assessment.
- Potential Impacts of Power Transmission: Members of the public asked about transmission cables and interconnection on land, including if BOEM will conduct an EA or environmental impact statement (EIS) on undersea transmission cables and who would be responsible for conducting a transmission assessment. Questions were also asked about survey grids that would be used for power transmission outside of the leasing areas.
- <u>Lease Details and Timing</u>: Questions were asked for more information about lessees' rights of way and use easements in the ocean and their duration. Members of the public also wanted to know how long the site assessment and characterization phase could take.
- <u>Coordination with the State of Oregon</u>: Attendees asked about coordination with and/or funding to State of Oregon agencies in the development of OSW. The public asked if BOEM would work with the Oregon Department of Fish and Wildlife (ODFW) to engage in the NEPA

- process and if BOEM would be involved in any of the State's Coastal Zone Management Act (CZMA) review process.
- <u>Public Comment Process</u>: Members of the public asked how BOEM will use comments on the draft EA to inform the final EA and if BOEM would respond to the comments submitted by the public.

# f. Opportunity for Public Comment

Jamie Damon, K&W, transitioned the meeting to the public comment opportunity. She reminded attendees that the court reporter present would capture their comments verbatim and submit them to BOEM for posting to regulations.gov, Docket BOEM-2023-0065. She highlighted the types of information BOEM is looking for, including potentially significant issues to be analyzed in the EA, sources of information to be included in the EA, and potential data gaps and information needs. A summary of public comments organized by key themes is provided below.

- Scope of the EA: Many commenters expressed concerns that the scope of the EA is too narrow and did not adequately consider cumulative environmental, economic, or cultural impacts. Commenters expressed the desire for BOEM to more thoroughly analyze potential impacts on marine wildlife and habitats, commercial fishing, and Tribal cultural resources.
- Programmatic Environmental Impact Statement (PEIS): Building off the previous theme, a significant number of commenters requested that BOEM conduct a PEIS to assess the potential biological, economic, and cultural impacts of floating offshore wind (FOSW) along the West Coast of the United States. Commenters believe this would allow for a more comprehensive and thorough analysis of the potential cumulative impacts of FOSW rather than assessing them at a state-specific level. These commenters shared their belief that a PEIS would address many of their concerns about gaps in data and analysis that they believe are present in the current EA.
- <u>Tribal Consultation</u>: Commenters shared their desire for BOEM to make meaningful efforts to engage and reach consensus with Tribes about the potential impacts of FOSW on Tribal resources.
- Requests for Comment Period Extension: Several commenters requested an extension of the draft EA comment period.

# g. Closing Remarks

Lisa Gilbane, BOEM, thanked attendees for their time and comments on the draft EA. She noted the next steps in the EA process and reminded attendees about BOEM's upcoming meetings related to OSW leasing in Oregon.
