


Auction Mechanics


High-Level Overview of Ascending Clock Auction

- All eight lease areas are offered simultaneously
- An “asking price” is announced for each lease area before every bidding round
- To remain active in the auction, a bidder must submit a live bid for a lease area (or have a previous live bid carried forward) in every round
- After every bidding round, the auction manager discloses the number of live bids received for each lease area and raises the asking price of any lease area that has received two or more live bids
- Closing rule: The auction concludes when each lease area has received at most one live bid


Schematic of Ascending Clock Auction Process

Bidding Detail (as proposed in PSN)

- Eight lease areas; each bidder can bid for only **one** lease area at a time and can win at most **one** lease area
- Live bids
 - In round 1, a bidder places a live bid on one of the lease areas
 - In subsequent rounds, the bidder can freely switch among lease areas, subject to the constraint that if the bidder was the only one who placed a live bid on a given lease area in the previous round (i.e., if demand = 1), the bidder must stay on the same lease area (at the same price)
- Exit bids
 - An exit bid can only be submitted for the lease area bid in the previous round, and only when the previous round's bid was contested
 - An exit bid must be for more than the previous round's asking price for the lease area and for less than the current round's asking price for the lease area
 - The exit bid is the last bid that a bidder can submit in the auction; when a bidder submits an exit bid, the bidder can no longer bid on any lease area (live bid or exit bid) in subsequent rounds


Winner Determination (as proposed in PSN)

- The highest bid received by a lease area in the final round (whether live bid or exit bid) becomes a provisionally winning bid
- If a lease area did not receive any bids in the final round, it is allocated to someone who bid for it in a prior round, so as to maximize auction revenues subject to each bidder winning at most one lease area
- Ties (e.g., identical exit bids, or more than one live bid for a lease area in a prior round) are resolved by randomization within the auction system

Bidding Detail (alternative described in PSN)

- Eight lease areas; each bidder can bid for up to **two** lease areas at a time and can win at most **two** lease areas
- Live bids
 - In round 1, a bidder places a live bid on up to two of the lease areas
 - In subsequent rounds, the bidder can freely switch among lease areas, subject to the constraint that if the bidder was the only one who placed a live bid on its given lease area(s) in the previous round (i.e., if demand = 1), the bidder must stay on the same lease area(s) (at the same price(s))
- Intra-round bids
 - An intra-round bid can only be submitted for the lease area(s) bid in the previous round, and only when the previous round's bid was contested
 - An intra-round bid must be for more than the previous round's asking price for the lease area(s) and for less than the current round's asking price for the lease area(s)
 - Submitting an intra-round bid irrevocably reduces a bidder's eligibility from two lease areas to one, or from one lease area to zero








