# Input Status Report for New York Bight Programmatic Environmental Impact Statement: November 2023 Environmental Justice Forum

## Introduction

BOEM is preparing a Programmatic Environmental Impact Statement (PEIS) for offshore wind development in the New York Bight lease areas. To support the PEIS and to inform decision making on offshore wind planning and development in the New York & New Jersey area, BOEM hosted an Environmental Justice (EJ) Roundtable Convening on Offshore Wind in the New York & New Jersey Region on July 21, 2022. Following the Roundtable, BOEM established a series of quarterly forum meetings — referred to as the Environmental Justice Forums, or EJF — to continue engagement on environmental justice issues.

At the Roundtable and the first EJF, BOEM heard from federal and state partners and community-based organizations who serve or work with environmental justice and underserved communities. Participants provided input on how BOEM should pursue engagement with environmental justice and underserved communities in the region moving forward. They also shared ideas on potential issues and impacts that may affect environmental justice and underserved communities from offshore wind energy development in the New York & New Jersey area.

Much of the information provided in the Environmental Justice Roundtable Convening and EJFs will inform the New York Bight PEIS. Other information and concerns shared through the series will likely be applicable to BOEM's reviews of Construction and Operations Plans submitted by lessees, and some information will likely be of interest to other federal and state partners.

# Purpose

The input-status report communicates to Roundtable and EJF participants how information they share during engagement efforts is processed by BOEM. The status report captures potential environmental justice impacts identified during the July 2022 New York & New Jersey Environmental Justice Roundtable Convening, the first quarterly form held on October 26, 2022, and the subsequent quarterly forums held on January 25, 2023, April 26, 2023, July 26, 2023, and November 8, 2023. Subsequent status reports will include additional information provided at quarterly forums and updates on how BOEM is handling identified topics or issues.

## Information Flow Process

BOEM intends that all input shared in the New York & New Jersey Roundtable and EJF is shared with appropriate entities, whether or not the issues are under BOEM's jurisdiction and authority or are addressed in BOEM's National Environmental Policy Act (NEPA) documents. In the context of incorporating information into the New York Bight PEIS, BOEM considers whether the input or issue is



within the scope of the PEIS; that is, relevant to the environment and human setting of the New York Bight or to potential impacts in the area of analysis. Some input may be more relevant to reviews of project-specific Construction and Operations Plans. BOEM also considers whether it has authority to address an issue or whether another entity, such as another federal or state agency, should address an issue under its mission and authority. Additionally, some of the information shared in the Roundtable and EJF may be informative to lessees or to community-based organizations and other organizations working on environmental justice issues.




Figure 1: Information Flow Process for Input Provided for the New York Bight PEIS

BOEM considers a number of questions to process input provided through the EJ Roundtable and Forums, as shown in Figure 1.

# Input and Progress

Input from November 8, 2023 Environmental Justice Forum

During the EJF on November 8, 2023, participants joined both in person and virtually. The in person participants attended a site visit at UPROSE and the South Brooklyn Marine Terminal. The in person and virtual participants heard from CBO representatives for a panel discussion on the impacts of offshore



wind development in their communities. Participants then participated in breakout group discussions on specific topics including workforce development, PEIS engagement, state and federal partnerships, and stakeholder best practices. The presentation and meeting summary from the forum are available on the Environmental Justice Forums webpage. The following input was shared:

#### Workforce Development

- Clarify which jobs created by offshore wind are considered "direct jobs" or "indirect jobs."
   [A.25]
- Increase transparency of when OSW jobs will be available (e.g., share that most jobs won't be offered for years). [A.26]
- There needs to be work done to clearly identify the entry-level jobs in the OSW industry, and then clearly communicate this to communities. [A.27]
- Prepare workers for jobs in offshore wind and explore pathways and capacity building to train the needed offshore wind workforce now and into the future. For example: [B.39]
  - o Develop bridge programs.
  - o Create career readiness programs.
  - o Demonstrate how careers fit into offshore wind.
  - o Design programs which illustrate transferrable skills.
  - Develop apprenticeship programs. Support unions in setting realistic expectations.
  - o Partnerships with minority and low-income serving institutions that are already structured to support career development.
  - o Connecting with elementary and middle schools to build programs that will help develop skills for students early on.

#### Accessibility and Materials

- All materials related to the NEPA and PEIS comment process should be translated into multiple languages to reach a broad audience. [B.02]
- Materials related to the PEIS need to be written accessibly and in layman's terms, avoiding jargon. [B.20]
- BOEM should consider parsing out which parts of the PEIS document are most relevant to environmental justice, and provide summaries of each appendix in the PEIS in a way that is more readily accessible to communities. [B.21]
- BOEM should consider articulating more clearly to the general public what is NEPA, what is a
  PEIS, and why it matters that people take the time to provide public comment, in addition to
  making clear what parts of the PEIS might be influenced by public comment, and which pieces
  are set. [B.22]
- BOEM should consider working to make the website more user-friendly, both online and on mobile. [B.23]
- BOEM should consider developing a graphic or flow chart that explains all opportunities available for public feedback related to the lease areas, and how the PEIS process fits into other feedback processes. [B.24]

### *Improving Education & Outreach*

- To improve outreach to communities, BOEM and other federal agencies should consider: [B.25]
  - o Hiring someone with an organizing background to lead this work.



- Providing support for local institutions (CBOs, libraries, places of worship) to canvas where community members already convene, to spread the word about the PEIS process.
- o Developing communications that look to OSW success stories in other countries, which can build enthusiasm within local communities around the potential benefits of OSW.
- O Developing a "Know Your Rights" style campaign to increase public awareness and civic engagement through the NEPA process.
- o Expanding outreach beyond legal placements and leverage social media.
- o Running an outreach campaign targeting CBOs who can act as intermediaries and 'translators' of information to their communities. These CBOs will need financial support to take on this labor. [B.17]
- o "Street teams" should be utilized to get information out to communities.
- The 45-day comment period is too short outreach and education around the PEIS need to happen far in advance, so people feel prepared once the comment period begins. [B.08, B.19, B.26]
- Multiple ways of engagement should be offered, such as forums, pop-up events, summits, flyers, learning circles (UPROSE), creative engagement that incorporates arts, as well as existing engagement pathways that community members are already familiar with. [B.32]
- BOEM should consider how input status reports can be used for education. [B.38]

## Develop Helpful Resources

- Develop a directory or organization chart of the federal and state agency OSW points of contact as a resource for CBOs. [B.27]
- Federal and State agencies should work with lessees to gather and provide information about the number of jobs anticipated throughout the lifecycle of a given project and the pathways and skills required to obtain those jobs. [A.27]
- Federal and State agencies should publish a granular description of the number and types of jobs anticipated per megawatt of wind energy, on average. [A.27]

#### Stakeholder-specific Partnership/ Engagement Considerations

- Unions should be included in the EJF. [C.10]
- Tribes need resources to develop the skillset and time required to review and understand the data provided by offshore wind projects. Suggestions include: [B.28]
  - o Federal Agencies should provide consultants to interpret the analyses.
  - The Bureau of Indian Affairs (BIA) has resources that could support interpreting the data for tribes.

## Trust Building

- Federal agencies (mainly BOEM) could do more to build trust with states, communities, and tribes. For example, BOEM should show up to state-led and other community meetings and celebrations, and not show up just when something is needed. [B.29]
- Federal government entities can and should utilize existing networks and resources of local groups, which have developed their own hubs for communication and information sharing with the communities they serve. [B.30]



- Make the purpose of engagement clear and offer a meaningful connection with people. Communities should have a clear understanding about what they will get out of engaging in the forums and other engagements. [B.31]
- There is a need for a two-way dialogue between community organizations and developers. [B.09]
- Government entities like BOEM can take a more hands-on role in ensuring accountability from developers. [B.06]
- More conversations should be had around community benefits agreements and financial modeling that can ensure that future prosperity from the growth of offshore wind can be more shared and equitable. [B.05, B.12]
- Challenge the language developers use in their contracts around "best faith efforts," and move beyond that to ensure greater accountability. [B.06]

### **Engagement Considerations**

- BOEM should conduct further background research on community history, the region, environmental injustices, existing organizations, coalitions, and other relevant contexts. [B.16]
- Participants shared that the EJF space should be continued and expanded as much as possible. [C.12]
- Capacity building for a diversity of community-based organizations, particularly those that are
  more representative of the community and may not be knowledgeable of offshore wind, is
  worth considering. Invest in capacity building for CBOs to get involved to educate about
  benefits and impacts of offshore wind. [B.33]
- BOEM should consider ways to integrate broader Indigenous communities within the process and recognize the foundational environmental injustices towards Tribes. [B.34]
- Intergenerational forms of engagement should be considered. [B.35]
- Local politicians should be utilized for broader engagement. [B.36]
- To keep momentum, work should continue between forums, not only engaging in discrete events. [C.13]
- It was suggested that community members be invited to participate in the EJF. [B.17]

#### **Partnerships**

- Build partnerships with existing networks and coalitions and learn more about community groups and their initiatives. [B.30]
- BOEM should conduct asset mapping to determine potential gaps and opportunities for partnerships. [B.37]
- BOEM should create space for discussion around developing a shared objective in the EJF. [C.11]

## *Input Tracking and Status*

BOEM shared the above issues, along with themes and issues from the July 2023, April 2023, January 2023, and October 2022 quarterly forums and the July 21, 2022 EJ Roundtable, with the New York Bight PEIS team and is working through addressing many of the concepts, as applicable. The following table indicates progress and status of BOEM's processing of the issues identified during the Roundtable, October 2022 EJF, January 2023 EJF, April EJF, July 2023 EJF, and November 2023 EJF. BOEM will update



the status of these issues and additional input and issues from each EJF throughout the development of the PEIS.
